

Kayne Anderson NextGen Energy & Infrastructure Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at April 30, 2021

Houston, TX – May 3, 2021 – Kayne Anderson NextGen Energy & Infrastructure, Inc. (the "Fund") (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the "1940 Act") as of April 30, 2021.

As of April 30, 2021, the Fund's net assets were \$396 million and its net asset value per share was \$8.39. As of April 30, 2021, the Fund's asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 453% and the Fund's asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 381%.

The Fund had 47,197,462 common shares outstanding as of April 30, 2021.

As of April 30, 2021, equity and debt investments were 99% and 1%, respectively, of the Fund's longterm investments of \$535 million. Long-term investments were comprised of Midstream Company (35%), Renewable Infrastructure Company (22%), Utility Company (22%), Natural Gas & LNG Infrastructure (18%), Other Energy (1%), Other (1%) and Debt (1%).
