

## **Kayne Anderson NextGen Energy & Infrastructure Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at June 30, 2021**

Houston, TX – July 1, 2021 – Kayne Anderson NextGen Energy & Infrastructure, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of June 30, 2021.

As of June 30, 2021, the Fund’s net assets were \$424 million and its net asset value per share was \$8.99. As of June 30, 2021, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 461% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 374%.

The Fund had 47,197,462 common shares outstanding as of June 30, 2021.

As of June 30, 2021, equity and debt investments were 99% and 1%, respectively, of the Fund's long-term investments of \$572 million. Long-term investments were comprised of Midstream Company (39%), Utility Company (20%), Renewable Infrastructure Company (20%), Natural Gas & LNG Infrastructure (18%), Other Energy (2%) and Debt (1%).
